3. Articles 39, 40, 41, 42, 43, 44, 45, 46, 47 and 48 of the Proclamation are renumbered as Articles 40, 41, 42, 43, 44, 45, 46, 47, 48 and 49th respectively, and the following new Article 39 is added:

“39”፡- **Powers and Duties of the Planning Bureau**

The Planning Bureau shall have the powers and duties to:

1. based on national development strategy, Develop a short-term and long-term plans; and implement it when upon approval;
2. Develop a long-term plan (five or ten years) and conduct periodic monitoring and evaluation towards the implementation of plan;
3. Collects, analyzes and archives data related with the natural resources in agriculture, industry, manufacturing and submit to the government and other concerned parties.
4. Cause the undertaking of surveying, mapping and Geographical studies towards the settlement Patterns, Agriculture, livestock, Basin and land arrangement Patterns, and ensure that this data’s ought to be a baseline for the development programs and projects;
5. Prepares socio-economic studies of the Region and ensure that the recommendations are implemented.

- 9. Waxaa uu soo saaraa documentiyada, habraacyada iyo hagayaasha qorshayaasha horumarineed ee natiijada ku salaysan ee heerarka kala-duwan ee qaab-dhismeedka dawladda.
- 10. Waxa uu dhisaa, kobciyaa islamarkaasna horumariyaa nidaamka dabagalka iyo qiimeynta natiijada kusaleysan ee heerarka kala-duwan ee qaab-dhismeedka dawladda.
- 11. Waxaa uu fulinayaa nidaamka daraasaadka xogta ee lagu soo ururinayo xogaha hab deegaaneedka iyo tirakoobka ee loogu baahan yahay hawlaha qorsheynta ee deegaanka.
- 12. Waxa uu xaqiijiyaa in qorsheyaasha waqtiga gaaban ee xafiisyadu ay waafaqsan yihiin yoolasha qorshaha waqtiga dheer ee qaybta (sectoral plan) iyo qorshaha guud ee waqtiga dheer ee heer deegaan iyo heer qaran.

- 9. Issue results-oriented regional development plans manuals, guides and documents;
- 10. Establish an indicator-based monitoring & evaluation system based on results and apply to various levels of structures.
- 11. Develop and implement GIS and statistical data analysis system for regional planning.
- 12. Ensures that the short term plan of the state government offices is in line with the long-term goals of the sector;
- 13. Issues guidelines and manuals to assist in the implementation of the region's demographic policy;
